#### **REMINDERS CONCERNING THE CERTIFICATES:**

- 1. There will be no replacement certificates issued.
- 2. The certificate is <u>not valid</u> until the student turns sixteen years of age and has held a learner's license for at least six months.
- 3. Once the student turns sixteen and has held a learner's license for six months they may take the ALEA/SDE certificate, along with their learner's license, to the ALEA office (not the probate office) and obtain a driver's license.
- 4. The certificate cannot be laminated or altered in any manner.
- 5. Passing Driver Education does not guarantee that the student will receive the ALEA/SDE driver's license certificate.
- 6. The certificate is not a valid document to use in lieu of a driver's license.
